Thank you for the opportunity for us to provide the following inputs for the Multicultural Framework Review.

## 1. Reaffirming Multiculturalism:

Noel Pearson introduced the concept that Australia's national heritage comprises three key components: "our ancient heritage, our British inheritance, and our multicultural triumph." Multiculturalism is one of these integral elements of Australia's identity. Upholding multiculturalism is essential for the ongoing social cohesion and success of this country.

It has been six years since the Turnbull government's 2017 statement, "Multicultural Australia: United, Strong, Successful," was issued. It is now appropriate to consider issuing a new statement on multiculturalism, reaffirming Australia's enduring commitment to this fundamental cornerstone that has made Australia one of the most successful multicultural societies in the world.

## 2. Fostering Sense of Belonging:

This was evident during the COVID-19 pandemic when multicultural communities were actively engaged, listened to, and included in the response and vaccination campaign, leading to a positive outcome of keeping the community safe.

Multicultural communities are valuable assets that enrich and strengthen our nation. Their diverse experiences, unique perspectives, and international connections are advantageous for trade and fostering people-to-people friendships. It is essential to acknowledge and celebrate these contributions.

4. Encouraging Participation in Democratic Processes and Public Affairs:

Consider strategies to encourage and promote greater participation of multicultural communities in democratic processes and public affairs, ensuring their equitable representation at all levels of representative bodies.

5. Addressing Aged Care Needs:
